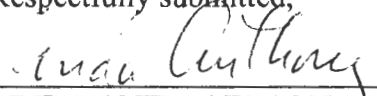
Mayor Anthony canceled the executive session

Motion to adjourn the meeting made at 7:12 p.m. by Councilmember Plunkett with a Second by Mayor Pro Tem Walker.

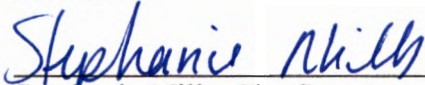
Motion to Adjourn carried unanimously by a vote of 5 ayes to 0 nays
