Motion to Cancel the November 24, 2021 and December 22, 2021 City Council Meetings made by Councilmember Plunkett with a Second by Councilmember Bowman

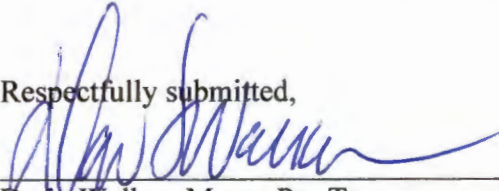
Motion carried unanimously by a vote of 5 ayes to 0 nays
